If this mobile replaces another mobile on this lot, I agree that the old mobile shall be removed from Indian Harbor within 15 days after replacement mobile is install. I understand that **after 15 days a penalty of \$10.00 per day will be assessed against me until the removal of the old mobile is accomplished.**

Submitted with this request is the required fee of \$500.00. I understand that if this mobile is not skirted within 30 days, as required by the Restrictions, **a penalty of \$5.00 per day will be assessed until such skirting has been accomplished.**

If this permit is disapproved for any reason, the permit fee will be returned.

I understand that the **PERMIT MUST BE POSTED ON THE LOT** during set up and clean-up in a manner so as to be clearly visible from the street. **A \$25.00 penalty will be assessed to me if the Permit is not posted.**
